- 1) The Candidate must have passed the Higher Secondary Certificate (HSC) Examination or any other examination equivalent to 10+2 HSC examination of any recognized Board / University / College with at least 50% marks taken together for Physics, Chemistry and Biology and the candidate should bring original statement of marks.
- 2) The Candidate should bring the documents in two files- one containing original and second containing three attested photocopies of these documents. The size of the file should be 14 inches x 11 inches (approx.)
- 3) The documents should be arranged as follows
  - i) Statement of marks of standard XII (HSC) examination.
  - ii) Statement of marks of standard X (SSC) examination.
  - iii) Proof of date of birth, nationality and domicile.
  - iv) School Leaving / Transfer Certificate or Migration Certificate.

- v) Caste Certificate and Caste validity certificate in case of reserved candidates.
- vi) Medical fitness certificate from a registered medical practitioner.
- vii) An affidavit in model format given in Annexure III (Page no. 30 of information brochure and application Form) signed by the candidate and countersigned by the parent / guardian in the presence of a notary on Rs. 100/- non judicial stamp paper.
- viii) Four copies of recent passport size photograph (developed from the same negative) with the candidate's name written on the back side.
- ix) Character Certificate from responsible person.
- x) AICET-10 admit card and statement of marks.

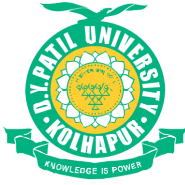
